V. Budget

- 1. We are on track to show net income of \$53k
- 2. This is a \$47k increase to the FY23 budget
- 3. Next year's budget—we broke out income and expense categories to improve transparency
- 4. Fiscal 2024 does not include a major gala or fundraiser but does project increased fundraising support for other activities.
- 5. We are committed to diversifying funding sources
- 6. We are working with contractors while we determine full time needs

Board recommends that the proposed budget is approved.

- Q. Kathy Collins What does PMP stand for?
 - ► A. This is the per member payment. We make payments to the national and state chapters per member. Members of the NYC chapter

We broke out PMP this year instead of including it in 'expenses' like past years. We anticipate that 2024 we will have more members since during presidential election years we get more members.

- ▶ Q. Kathy- how much does state and national get?
 - ▶ A. Two thirds of membership dues are paid to the State and National Leagues. The State does a lot of studying and advocacy at state level, and same at national level, and also for national election laws. We also get some funding from the National League and state chapter periodically. We rely on other sources of revenue, not memberships for our operating budget.
- Q. Mary Jenkins- Is a contract staff more expensive?
 - A. Yes, but it will help us maximize their usage and have specialists for specific purposes. For example, we worked with a website development team on the new website design and launch this past year.
- ▶ Q. Gladys Krasner- If the opportunity to move offices came up, do we need a moving fund or do we have that in the budget now, can we cover that expense with our current budget?
 - ▶ A. If we moved to a more expensive place, we would need to have a board vote. We do not anticipate moving currently, and this is not included in the budget.

- ▶ Q. Kate Doran- Where is the rent reflected in the expenses?
 - ► A. In facility expenses \$36k was budgeted. \$20k is actually what we expected to spend. Last year we were thinking about some flex/ additional space or moving to a different location but we didn't end up needing that.

Motion to approve fiscal budget for 2024. Budget was already approved by the board so we do not need a second.

Motion passes.

 - ► A. This will be a study, and we will do our own research and consult with experts, good government groups, academics and other Leagues that might have positions.
- ▶ Q. Helen Meltzer Krim- Would it require a change to the NY State constitution?
 - A. Yes
- ▶ Q. Other attendee- Besides higher voter turnout, what are the benefits?
 - ▶ A. All the positions being voted on locally are very important. A broader electorate base and more voters may participate, but we need to do the study to determine whether the League should take a position.
- ► C. Comment: Kathy Collins- This will benefit people with disabilities.
- Q. Other attendee- It sounds like a conclusion has been reached already, is this the case?
 - ▶ A. No, we are spending the upcoming term researching this and benchmarking other places where the local elections have been aligned. It is a study, there are many different organizations, such as Common Cause and

Campaign Finance Board with whom we will consult.

- ► C. Comment: Helen Meltzer Krim- It would save a ton of money.
- ► C. Other attendee- I want to remind people that pros and cons are part of the study.
- ▶ Q. Bella Wang- Would this go to a vote if the study finds that this is a good idea?
 - A. Yes
- Q. Gladys Krasner- Karol, on procedure, we have a City Affairs committee now. Is that the appropriate group?
 - ► A. The Board will determine the appropriate committee if the vote passes.

Motion to vote to accept local program as proposed. Vote passes.








Stacy Lesser, VP Communications


Stacey joined the LWVNYC in 2022, and has been an active member of the Development Committee as well as taking on responsibility for the League newsletter. Her engagement

The Bylaws Committee is proposing a number of changes to the LWVNYC Bylaws. Some of these modifications address the change in membership structure that LWVUS will be implementing starting in January/February 2025. Membership in the League currently is a "bottom-up" process. Members join at the local league level and pay their dues to the local chapter. The local league then sends payments to the State and National Leagues based on the number of members. Starting in 2025, the process will change to a "top-down" approach: all members will join/renew at the National level. When you join or renew on the LWVNYC website, it may not appear to be different to our members, but the link will actually go into the National membership system, not our local one. As a result, we need to include changes into our Bylaws to reflect the new process.

In addition to the membership changes, the committee proposed a number of other changes to simplify and clarify the intent of our Bylaws.

The Bylaws Committee recommends the following changes:

ARTICLE III: MEMBERSHIP

Section 2: Types of Membership

Must amend due to new National Membership changes that will conflict with existing local Bylaws.

Current wording:

a) Voting Members. Persons of at least 16 years of age, who upon payment of dues, join the LWVNYC, shall be voting members of the Local Leagues, the state Leagues

and LWVUS; provided that,

- i. persons who reside within the area of a Local League may join that Local League or any other Local League
- ii. persons who reside outside the area of any Local League may join a Local League or shall be state members-at-large; and
- iii. any person who has been a member of the League for 50 years or more shall be a life member excused from the payment of dues.
- iv. Student members any individual who is attending an accredited institution of education either full or part time. Student members under the age of 16 are associate members.
- b) Associate Members. All others who join the LWVNYC shall be Associate Members. Associate Members are not voting members.
- c) *Initial Members*. The initial members of the LWVNYC shall be the members of the previously existing The League of Women Voters of the City of New York, Inc. as of the effective date of the Merger.

Proposed wording:

A. Voting Members. Persons at least 16 years of age who join the League shall be voting members of local Leagues, state Leagues and of the LWVUS; (1) those who live within an area of a local League may join that League or any other local League; (2) those who reside outside the area of any local League may join a local League or shall be state members-at-large; (3) those who have been members of the League for 50 years or more shall be life members excused from the payment of dues; (4) Those who are students are defined as individuals enrolled either as full

Report of the Bylaws Committee or part time with an accredited institution.

B. *Associate Members*. All others who join the League shall be associate members.

ARTICLE IV: OFFICERS Section 6: The Treasurer

Specify financial statements to present to the Board.

Current wording:

The Treasurer or a duly appointed Assistant Treasurer shall collect and receive all monies due. The Treasurer shall be the custodian of these monies, shall deposit them in a bank designated by the Board, and shall disburse the same upon order of the Board. The Treasurer shall present statements to the Board at its regular meetings. The financial records of the organization shall be reviewed annually by a certified public accountant.

Proposed wording:

The Treasurer or a duly appointed Assistant Treasurer shall collect and receive all monies due. The Treasurer shall be the custodian of these monies, shall deposit them in a bank designated by the Board, and shall disburse the same upon order of the Board. The Treasurer shall present, at a minimum, a statement of financial activities and a statement of financial position statements to the Board at its regular meetings. The financial records of the organization shall be reviewed annually by a certified public accountant.

ARTICLE V: BOARD OF DIRECTORS

Section 1: Number, Manner of Selection and Term of Office

Don't require a Chairperson of the Board.

Current wording:

b) At the first meeting of the Board after the Annual

Meeting, the Board shall elect a Chairperson of the Board (the "Board Chair") from among the Board members, other than any director who is also serving as the President. The Board Chair shall, in conjunction with the President, develop the agenda for the meetings of the Board, and shall act as advisor to the President. The Board Chair shall be an ex officio member of all committees of the Board, except the Nominating Committee. No one shall serve more than six consecutive years as Board Chair.

Proposed wording:

b) At the first meeting of the Board after the Annual Meeting, the Board shall may elect a Chairperson of the Board (the "Board Chair") from among the Board members. other than any director who is also serving as the President. The Board Chair shall, in conjunction with the President, develop the agenda for the meetings of the Board, and shall act as advisor to the President. The Board Chair shall be an ex officio member of all committees of the Board, except the Nominating Committee. No one shall serve more than six consecutive years as Board Chair. If no Board Chair is elected, the President shall serve as Chair of the Board.

Section 6: Meetings

Update communication methods.

Current wording:

There shall be at least six regular meetings of the Board annually. The Board Chair may call special meetings of the Board and shall call a special meeting upon the written request of five members of the Board. Members of the Board shall be notified of the time and place of any special meeting by written notice, transmitted electronically, by mail, or fax sent at least five (5) business days prior to such meeting. The Board Chair shall preside at the Board meetings.

Proposed wording:

There shall be at least six regular meetings of the Board annually. The Board Chair may call special meetings of the Board and shall call a special meeting upon the written request of five members of the Board. Members of the Board shall be notified of the time and place of any special meeting by written notice, transmitted electronically, or by mail, or fax sent at least five (5) business days prior to such meeting. The Board Chair shall preside at the Board meetings.

ARTICLE VII: FINANCIAL ADMINISTRATION Section 2: Dues

Must amend due to new National Membership changes that will conflict with existing local Bylaws.

Current wording:

Membership dues shall be payable during the month in which the member joined. The Board may establish special procedures for collection of dues. The dues structure shall be as determined by the Board.

Proposed wording:

Membership dues shall be payable during the month in which the member joined. The Board may establish special procedures for collection of dues. The dues structure shall be as determined by the Board. Members shall pay dues in accordance with LWVUS policy.

ARTICLE VIII: MEMBER MEETINGS

Section 1: Notice

Update communication methods.

Current wording:

There shall be at least one meeting of the membership each year, which shall be designated the Annual Meeting. Any other meeting of the Members shall be designated a Special Meeting. Notice of any meeting shall be given to all members at least 30 days prior to the meeting electronically, by mail, or fax.

Proposed wording:

There shall be at least one meeting of the membership each year, which shall be designated the Annual Meeting. Any other meeting of the Members shall be designated a Special Meeting. Notice of any meeting shall be given to all members at least 30 days prior to the meeting electronically, or by mail, or fax.

Section 4: Quorum

Update communication methods.

Current wording:

One hundred voting members, or 10% of the total members entitled to vote, whichever shall be less, shall constitute a quorum at any meeting of the Members. The record in the office of the LWVNYC of paid-up voting members as of 45 days prior to a meeting shall determine the members entitled to vote at the meeting or any adjournment thereof. Any member entitled to vote may designate, by written proxy, transmitted electronically, by mail, email, or fax, another member to be present to vote in their stead. All proxies must be received at the LWVNYC office no later than three (3) business days prior to the meeting.

Proposed wording:

One hundred voting members, or 10% of the total members entitled to vote, whichever shall be less, shall constitute a quorum at any meeting of the Members. The record in the office of the LWVNYC of paid-up voting members as of 45 days prior to a meeting shall determine the members entitled to vote at the meeting or any adjournment thereof. Any member entitled to vote may designate, by written proxy, transmitted electronically, or by mail, email, or fax, another member to be present

Report of the Bylaws Committee to vote in their stead. All proxies must be received at the LWVNYC office no later than three (3) business days prior to the meeting.

Section 5: List or record of members at Annual Meeting

Update communication methods.

Current wording:

A list or record of members entitled to vote, certified by the LWVNYC Secretary, who shall be responsible for its preparation, shall be produced at each meeting, upon request therefor of any member who has given notice by email, fax or other electronic method to the Secretary provided that such request will be made at least 10 days prior to such meeting. If the right to vote of any person at the meeting is challenged, the Election Committee shall require such list or record of members to be produced as evidence of the right of the person(s) challenged to vote at such meeting. All persons who appear from such list or record to be members entitled to vote thereat may vote at the meeting.

Proposed wording:

A list or record of members entitled to vote, certified by the LWVNYC Secretary, who shall be responsible for its preparation, shall be produced at each meeting, upon request therefor of any member who has given notice by email, fax or other electronic method to the Secretary provided that such request will be made at least 10 days prior to such meeting. If the right to vote of any person at the meeting is challenged, the Election Committee shall require such list or record of members to be produced as evidence of the right of the person(s) challenged to vote at such meeting. All persons who appear from such list or record to be members entitled to vote thereat may vote at the meeting.

ARTICLE X: PROGRAM

Section 5: Local League Action

Ensure compliance with the National League as well as the State League.

Current wording:

The LWVNYC may act only in conformity with, or not contrary to, the position taken by the LWVNYS.

Proposed wording:

The LWVNYC may act only in conformity with, or not contrary to, the position taken by the LWVNYS and the LWVUS.

ARTICLE I. NAME

Section 1. Name

The name of this organization shall be The League of Women Voters of the City of New York, Inc. ("LWVNYC"). LWVNYC's former name was League of Women Voters of the City of New York Education Fund, Inc. ("Ed Fund"), the surviving corporation of the merger ("the Merger") between the previously-existing The League of Women Voters of the City of New York, Inc. and Ed Fund. Ed Fund's name was changed to The League of Women Voters of the City of New York, Inc. pursuant to the certificate of merger filed with the Secretary of State on pursuant to Section 904 of the Not-for-Profit Corporation Law of the State of New York ("N-PCL").

LWVNYC is a local league (a "Local League") of The League of Women Voters of the United States ("LWVUS") and of The League of Women Voters of New York State ("LWVNYS"), and is an integral part thereof.

ARTICLE II. PURPOSES AND POLICY

Section 1. Purposes

The purposes of the LWVNYC are set forth in its Certificate of Incorporation (as amended from time to time) and include the promotion of political responsibility through informed and active participation in government and to act on selected governmental issues.

Section 2. Policy

The LWVNYC may take action on local governmental measures and policies in the public interest in conformity with the Principles of the LWVUS and LWVNYS. It shall not support or oppose any political party or any candidate.

Section 3. Diversity Equity and Inclusion Policy

LWVNYC is fully committed to ensure compliance — in principle and in practice — with LWVUS Diversity, Equity, and Inclusion Policy.

ARTICLE III. MEMBERSHIP

Section 1. Eligibility

Any person who subscribes to the purposes and policy of the LWVNYC shall be eligible for membership.

Section 2. Types of Membership

A. Voting Members. Persons at least 16 years of age who join the League shall be voting members of local Leagues, state Leagues and of the LWVUS; (1) those who live within an area of a local League may join that League or any other local League; (2) those who reside outside the area of any local League may join a local League or shall be state members-at-large; (3) those who have been members of the League for 50 years or more shall be life members excused from the payment of dues; (4) Those who are students are defined as individuals enrolled either as full or part time with an accredited institution.



B. Associate Members. All others who join the League shall be associate members.

ARTICLE IV. OFFICERS

Section 1. Enumeration and Election of Officers.

The officers of the LWVNYC (each, an "Officer") shall be a President or two Co-Presidents, or if deemed necessary by the Board, a management team consisting of as many people as is necessary to carry out the work of the LWVNYC (herein referred to as "President"), up to four Vice Presidents, a Secretary and a Treasurer. The Officers shall be elected for terms of two (2) years by the members at the Annual Meeting in even-numbered years or until their successors have been elected and qualified. They take office immediately upon the conclusion of the Annual Meeting.

Section 2. Qualifications.

Only voting members of the LWVNYC shall be elected or appointed to serve as Officers or Directors of the LWVNYC.

Section 3. The President.

The President shall preside at the Annual Meeting. The President shall sign contracts and other legal instruments together with another officer authorized by the Board. The President shall be an ex officio member of all committees except the Nominating Committee. The President shall have such usual powers of supervision and management as may pertain to the office of the

President and perform such other duties as may be designated by the Board.

Section 4. Vice Presidents.

The Vice Presidents, shall in the event of absence, disability or death of the President, possess all the powers and perform all the duties of that office, until such time as the Board shall elect one of its members to fill the vacancy. The Vice Presidents shall perform such other duties as the President and the Board may designate.

Section 5. The Secretary.

The Secretary shall keep the minutes of all meetings of the Board and of the Annual Meeting. The Secretary shall notify all Officers and Directors of their election. The Secretary shall perform such other functions as may be incident to the office.

Section 6. The Treasurer.

The Treasurer or a duly appointed Assistant Treasurer shall collect and receive all monies due. The Treasurer shall be the custodian of these monies, shall deposit them in a bank designated by the Board, and shall disburse the same upon order of the Board. The Treasurer shall present, at a minimum, a statement of financial activities and a statement of financial position to the Board at its regular meetings. The financial records of the organization shall be reviewed annually by a certified public accountant.

ARTICLE V. BOARD OF DIRECTORS

Section 1. Number, Manner of Selection and Term of Office.

- a. The Board of Directors (the "Board") shall consist of the Officers of the LWVNYC ("Officer Directors"), up to five but no fewer than three elected directors ("Elected Directors") and up to six appointed directors ("Appointed Directors" and, together with Officer Directors and Elected Directors, the "Directors"). The number of Elected Directors shall be recommended by the Nominating Committee (as defined below). The Officer Directors shall be elected at the Annual Meeting in even-numbered years, or at the next Annual Meeting if a vacancy in an elective office has occurred, and shall serve until the next election in an even-numbered year. The Elected Directors shall be elected in the Annual Meeting in odd-numbered years, or at the next Annual Meeting if a vacancy in an elective office has occurred, and shall serve until the next election in an odd-numbered year. The Officer Directors and Elected Directors shall appoint such Appointed Directors as they deem necessary, but not more than six, to help carry on the work of LWVNYC. The terms of office of the Appointed Directors shall be up to one year and shall expire at the next Annual Meeting. Directors, whether elected or appointed, shall be limited to six consecutive years in the same office.
- b. At the first meeting of the Board after the Annual Meeting, the Board may elect a Chairperson of the Board (the "Board Chair") from among the Board members. The Board Chair shall, in conjunction with the President, develop the agenda for the meetings of the Board, and shall act as advisor to the President.

The Board Chair shall be an ex officio member of all committees of the Board, except the Nominating Committee. No one shall serve more than six consecutive years as Board Chair. If no Board Chair is elected, the President shall serve as Chair of the Board.

Section 2. Qualifications.

Only Voting Members of the LWVNYC shall be elected or appointed or continue to serve as an Officer or Director of the LWVNYC.

Section 3. Vacancies and Absences.

Any vacancy occurring in the elected Board by reason of the resignation, death or disqualification of any member may be filled on an interim basis, until the next Annual Meeting, by a majority vote of all the remaining members of the Board. It shall be the function of the Nominating Committee to recommend to the Board candidates for vacancies in the elective offices occurring between elections. Absence of any member from three consecutive Board meetings, without valid reason, shall be deemed a resignation.

Section 4. Powers and Duties.

The Board shall have full charge of the property and business of the LWVNYC with the full power and authority to manage and conduct the same, subject to the instructions of the Annual Meeting. It shall plan and direct the work necessary to carry out the program as adopted by the National and State Conventions and the Annual Meeting. The Board shall create and designate such committees as it may deem necessary, which shall

include a committee on Diversity Equity and Inclusion. The Board may adopt, amend or discontinue such Standing Rules (as defined below) as it may deem necessary for the functioning of the Board.

Section 5. Standing Rules.

The "Standing Rules" are policies and guidelines to the Board for the carrying out of their duties, which are not contained in the Bylaws, and which shall be adopted, amended or discontinued as provided in these Bylaws.

Section 6. Meetings.

There shall be at least six regular meetings of the Board annually. The Board Chair may call special meetings of the Board and shall call a special meeting upon the written request of five members of the Board. Members of the Board shall be notified of the time and place of any special meeting by written notice, transmitted electronically or by mail, sent at least five (5) business days prior to such meeting. The Board Chair shall preside at the Board meetings.

Section 7. Quorum.

A majority of the members of the Board of Directors shall constitute a quorum, and a majority of the members in attendance at any board meeting shall, in the presence of a quorum, decide its action. Any member of the board may participate in a meeting by means of conference telephone or similar communications equipment that allows all persons participating in the meeting to hear each other at the same time; participation by such means shall constitute presence in person at a meeting.

ARTICLE VI. ADVISORY BOARD

The Board may appoint an Advisory Board representing the corporate, civic, cultural and philanthropic community of New York City who support the work of the LWVNYC. The size and composition of the Advisory Board shall be decided by the LWVNYC Board of Directors. The Advisory Board shall serve as a committee of LWVNYC as described in Section 712(e) of the N-PCL.

ARTICLE VII. FINANCIAL ADMINISTRATION

Section 1. Fiscal Year.

The fiscal year of the LWVNYC shall be from July 1 through June 30 of the following year.

Section 2. Dues.

Members shall pay dues in accordance with LWVUS policy.

Section 3. Budget.

A budget for the ensuing year shall be submitted by the Board to the Annual Meeting for adoption. The Budget shall include support for the work of the League as a whole.

Section 4. Budget and Finance Committee.

A Budget and Finance Committee shall be appointed by the Board of Directors at the first Board meeting following the Annual Meeting. The Budget and Finance Committee shall provide financial guidance and oversight, and shall,

at least four months prior to the Annual Meeting, prepare a budget for the ensuing fiscal year. The proposed budget shall be sent to all members at least 30 days before the Annual Meeting. The Treasurer shall not be eligible to serve as Chair of the Budget and Finance Committee.

ARTICLE VIII. MEMBER MEETINGS

Section 1. Notice

There shall be at least one meeting of the membership each year, which shall be designated the Annual Meeting. Any other meeting of the Members shall be designated a Special Meeting. Notice of any meeting shall be given to all members at least 30 days prior to the meeting electronically or by mail.

Section 2. Annual Meeting.

The Annual Meeting shall be held at a time and place to be determined by the Board (including, to the extent permitted by law, in virtual format). The Annual Meeting shall (a) elect officers and directors, (b) adopt a budget; (c) adopt amendments to the Bylaws; (d) adopt a local program for the ensuing one or two years; and (e) transact such other business as may properly come before it.

Section 3. Special Meetings.

Special Meetings of the Members may be called by the Board or by Members entitled to cast ten percent of the total number of votes entitled to be cast at such meeting, who may, in writing, including by e-mail, demand the call of a Special Meeting specifying the date and month thereof, which shall not be less than two nor more than three months from the date of such written demand. The Secretary upon receiving the written demand shall promptly give notice of such meeting, or if they fail to do so within five business days thereafter, any member signing such demand may give such notice. The Special Meeting shall be held at a time and place to be determined by the Board (including, to the extent permitted by law, in virtual format).

Section 4. Quorum.

One hundred voting members, or 10% of the total members entitled to vote, whichever shall be less, shall constitute a quorum at any meeting of the Members. The record in the office of the LWVNYC of paid-up voting members as of 45 days prior to a meeting shall determine the members entitled to vote at the meeting or any adjournment thereof. Any member entitled to vote may designate, by written proxy, transmitted electronically or by mail, another member to be present to vote in their stead. All proxies must be received at the LWVNYC office no later than three (3) business days prior to the meeting.

Section 5. List or record of members at Annual Meeting.

A list or record of members entitled to vote, certified by the LWVNYC Secretary, who shall be responsible for its preparation, shall be produced at each meeting, upon request therefor of any member who has given notice by email or other electronic method to the Secretary provided that such request will be made at least 10 days prior to such meeting. If the right to vote of any person at the meeting is challenged, the Election Committee shall require such list or record of members to be produced as evidence of the right of the person(s) challenged to vote

at such meeting. All persons who appear from such list or record to be members entitled to vote thereat may vote at the meeting.

ARTICLE IX. NOMINATIONS AND ELECTIONS

Section 1. Nominating Committee.

The immediate past President of the LWVNYC shall be the Chair of the Nominating Committee. In the absence of such person, the Board shall select one of its directors to serve in such a role. The Chair shall select at least two members of the LWVNYC, only one of whom shall be from the Board, to prepare a slate for the elective offices. It shall be one of the functions of the Nominating Committee to recommend to the Board candidates for vacancies in the elective offices occurring between elections. Suggestions for nominations for officers and directors may be sent to the Nominating Committee by any voting member, provided the consent of the nominee has been obtained. The President or Co-President of the LWVNYC shall not be a member of the Nominating Committee.

Section 2. Report of the Nominating Committee.

The report of the Nominating Committee, containing its nominations for officers and elected directors, shall be sent to the Members at least 30 days before the Annual Meeting. The report of the Nominating Committee shall be presented at the Annual Meeting. Nominations may be made from the floor by any voting member immediately after presentation, provided the consent of the nominee has been obtained.

Section 3. Election.

The Election Committee, appointed by the President at the Annual Meeting, shall be in charge of the election if it is by ballot. If there is only one nominee for each office, the election may be by voice vote. Officers are elected by majority vote of the members present, or voting by written proxy, and qualified to vote.

ARTICLE X. PROGRAM

Section 1. Authorization.

The governmental principles adopted by the National Convention and supported by the League as a whole constitute the authorization for the adoption of the program.

Section 2. Program.

The program of the LWVNYC shall consist of (a) action to implement the principles and (b) those governmental issues chosen at the Annual Meeting for concerted study and action.

Section 3. Adoption of Local Program.

a. a) The Board shall consider the recommendations for a local program sent in by the voting members. Voting members shall send their recommendations not later than 60 days prior to the Annual Meeting. An Ad Hoc Board committee shall consider all recommendations and draft a proposed Local Program. The draft proposal shall then be reviewed by the Board of Directors.

- b. The proposed program shall be sent to all members at least 30 days before the Annual Meeting.
- c. A majority of the qualified members present or by written proxy and voting at the Annual Meeting shall be required for adoption of any item in the proposed program as presented to the Annual Meeting by the Board.
- d. Recommendations for program items submitted by voting members 60 days prior to the Annual Meeting but not recommended by the Board may be considered by the Annual Meeting provided that the Annual Meeting shall order consideration by a majority vote.
- e. A three-fifths vote of those qualified members present or by written proxy at the Annual Meeting is necessary to adopt a non-recommended program item.

Section 4. Member Action.

Members may act in the name of the LWVNYC only when authorized to do so by the Board. They may act only in conformity with, a position taken by the LWVNYC, the LWVNYS and the LWVUS.

Section 5. Local League Action.

The LWVNYC may act only in conformity with, or not contrary to, the position taken by the LWVNYS and the LWVUS.

ARTICLE XI. NATIONAL CONVENTION AND STATE CONVENTION, AND STATE COUNCIL

Section 1. National and State Conventions

Nominations for delegates to a National or State Convention may be sent to the Secretary of the LWVNYC by any voting member not later than 60 days preceding that convention. From these nominations the Board shall elect by ballot delegates to the particular convention in the number allotted to the LWVNYC (or portion thereof) under the provisions of the Bylaws of the LWVUS and the LWVNYS. When less than a full delegation is to be sent, the apportioned number shall be determined each year by the Board of Directors in consultation with the Budget Committee.

Section 2. State Council.

The Board of Directors shall direct how LWVNYC votes are cast at the State Council.

Section 3. Alternates.

Alternates for the delegates to the National Convention shall be elected at the same time as delegates. The Board may empower the President and/or a committee to fill any vacancy in the event that the list of alternates shall have been exhausted.



ARTICLE XII. PARLIAMENTARY AUTHORITY

The rules contained in Robert's Rules of Order as revised, shall govern the organization in all cases to which they are applicable and in which they are not inconsistent with these Bylaws.

ARTICLE XIII. AMENDMENTS

Bylaws Committee.

A Bylaws Committee shall be appointed by the Board at least four months prior to the Annual Meeting to consider any proposals for amendments submitted by voting members. The report of the Bylaws Committee together with the Statement of the Board's recommendations on the separate proposals shall be submitted to the Annual Meeting for action.

- a. The report of the Bylaws Committee and the recommendations of the Board of Directors shall be sent to the members at least 30 days prior to the Annual Meeting.
- A two-thirds vote of those qualified members present or by written proxy at the Annual Meeting shall be required for adoption of the amendments to these Bylaws.

ARTICLE XIV. STATUTORY COMPLIANCE ARTICLE

Section 1. Conflict of Interest Protocols.

This Organization shall adopt, and at all times honor, the terms of a written conflicts of interest policy to assure

that its Directors, Officers and Key Employees act in the Organization's best interest and comply with applicable legal, regulatory and ethical requirements. The conflicts of interest policy of the Organization shall include, at a minimum, the following provisions:

- **a. Procedures.** Procedures for disclosing, addressing, and documenting Conflicts of Interest and Related Party Transactions to the Board of Directors, or authorized committee, as appropriate.
- **b. Restrictions.** Stipulations that when the Board of Directors, or authorized committee, as appropriate, is considering a real/potential conflict of interest, the interested party shall not:
 - i. be present at, or participate in, any deliberations;
 - ii. attempt to influence deliberations, and/or
 - iii. cast a vote on the matter.
- **c. Definitions.** Definitions of circumstances that could constitute a conflict of interest.
- d. **Documentation.** Requirements that the existence and resolution of the conflict be documented in the records of the Organization, including in the minutes of any meeting at which the conflict was discussed or voted upon.
- e. Audit-Related Disclosure. Protocols to assure for the disclosure of all real or potential conflicts of interest are properly forwarded to the Audit Committee or Conflicts of Interest Committee, as appropriate, or if there is no such Audit or Conflicts Committee, to the Board of Directors, or another Committee of the Board, as appropriate.

Local Program 2024-2025

Based on the Bylaws of the League of Women Voters of the City of New York, membership must adopt a local program for the upcoming year. Thank you to the members who submitted proposals and ideas.

For this upcoming year, the Local Program Committee and LWVNYC Board are recommending adoption of the Local Program:

How to Achieve Long Term, Stable Affordable Housing for New Yorkers

New York City is experiencing the most dramatic lack of access to affordable housing for low-to-moderate income New Yorkers in decades. According to the 2024 New York City Housing and Vacancy Survey, the overall NYC housing vacancy rate is at 1.4 percent, down from 4.5 percent in 2021 (when the last report was issued). New York officials consider a vacancy rate of less than 5 percent a "housing emergency." The data also shows that the housing crisis affects New York's lowest-income people the hardest and homelessness remains at an all-time high.

The League recommends a study to review issues such as the current public and public/private partnerships that create affordable housing; initiatives such as social housing; community land trusts; low-and-moderate income tenant conversion of small rental buildings; revisions to zoning restrictions, among other housing related issues.

The League has always supported government efforts to ensure the availability of affordable housing and we believe that through a comprehensive study on housing issues in NYC, we will advocate for social change, may determine new, positive housing initiatives and highlight existing successful policies and programs. LWVNYC will

also inform and educate our members on the most up-to-date housing affordability proposals and ideas. We will become educated advocates, which will allow us to take an informed League position(s) on particular housing proposals, join appropriate coalitions and support local legislation. The League believes that in order to have informed and active civic participation, New Yorkers must feel that they have long term, affordable housing stability.

CITY AFFAIRS COMMITTEE

Main objectives for committee

▶ City Affairs is a newly formed committee looking for members. Its objective is to help amplify the League's presence with New York City's 51 Council members and City Hall. Our outreach will include monitoring legislation, meeting with council members, and developing joint programs for their constituents that encourage active civic participation.

2023-2024 Accomplishments

- ▶ Organized and hosted an Open House for the newly sworn 2024 New York City Council in January, 2024. We had 11 members attend this event. Since that event, we have been in direct contact with 2 additional member offices.
- ▶ We hosted a two part Zoom workshop for all city council staff based on our League publication "What Makes New York City Run?" and featured Adrienne Kivelson, the book's original author, and Marco DeSena, Baruch College professor who edited and updated the 2024 edition. This two day event occurred April 9 and 16, 2024. 56 staff members across 18 district offices enrolled in the workshop and 23 attended. The workshop was recorded for those unable to attend or for those who did not initially enroll.
- ▶ We have actively attended numerous budget hearings of the City Council Committees as they prepared for their response to the mayor's 2025 budget. In total, our committee attended 6 hearings.

▶ We have been in direct contact with all 51 Member offices since February and in close contact with 4 offices for direct meeting opportunities to discuss several issues. These opportunities to speak directly with the Members will help us to broadcast our name to the Council and ensure they are aware of all the work that the League is able to do to help enrich their communities and constituents.

CRIMINAL JUSTICE REFORM COMMITTEE

Main objectives for committee

- ► Establish the LWVNYC as a collaborator and influencer around issues of criminal justice reform in NYC.
- ▶ Partner with community-based organizations and those directly impacted by the criminal justice system to advocate and lobby for legislation and policies that focus on reform.
- ► The Committee's interest will be to engage these partners and actively encourage people they work with to participate in the political process.
- ► Achieve reform in a system that has disenfranchised members of NYC's most vulnerable communities.

Summary of 2023-2024 Activities and Accomplishments

▶ Joined The Vote in NYC Jails Coalition (VJC) which is a group of legal service providers, government offices and community-based organizations dedicated to delivering the full promise of enfranchisement to people



currently incarcerated in jails.

- ▶ LWVNYC activities, as part of the VJC, included registering people to vote in jails and providing them with information and education regarding their voting rights, attending rallies and signing letters to the Department of Corrections and Board of Elections.
- ► Continued to partner with the Close Rikers Island coalition to ensure the timely and efficient implementation of closing Rikers and replacing the jail complex with four borough-based facilities.

DIVERSITY, EQUITY AND INCLUSION (DEI) COMMITTEE REPORT

Main objectives for committee

- ▶ The vision of the DEI Committee is to provide tools and open forums for discussion within the League so that it will comprehensively conduct its work both internal and external with an eye towards diversity, equity and inclusion. Such introspection and openness are important for the League to truly understand, represent and reflect the city we serve and empower all of voices and representation concerning civic engagement.
- ► The DEI committee is a Board level committee and engages regularly with the Board, including regular monthly updates and a shared commitment to our important work.

Summary of 2023-2024 accomplishments and activities

In the year plus since the DEI committee was established in its current form, the following are the Committee's accomplishments:

- Meet with other League committees to present and discuss what DEI means and how it intersects with their work
 - ▶ Members of each individual committee serve as liaisons with DEI committee
- ▶ Developed a self-assessment survey to use by League committee chairs and the Board as a tool for self-reflection and goal setting; results are being collected and discussions are beginning
- ► Establish monthly meetings that include the committee liaisons and other members, but are open to the wider League network
- ► Engage with members to develop best practices for disability access
- ▶ Develop a DEI event series with films, books, museum tours, etc., including outside speakers, meant to encourage thoughtful discussions on what DEI means in the context of the various media, protagonists and participants.
 - ▶ The first event was held in April which was a screening of My Name is Pauli Murray, followed by a hybrid discussion led by NYHS Scholar Salonee Bhaman
 - > Future activity includes a group visit to the Metro-



- politan Museum of Art to view the Harlem Renaissance exhibit and discussion of the art

In the year ahead, the committee will continue to use the self-assessment tool to establish goals for the League as it relates to DEI, and further incorporate League committees and their initiatives and members, as well as the wider community in this effort. We hope to use the event series to bring people together for some fun and interesting activities and shared enlightenment.

EDUCATION COMMITTEE

Main objectives for committee

- ► Expand the League's involvement in DemocracyReadyNY
- ► Continue participation in NYC Civic Coalition
- ► Allyship with YCI (Youth Civics Initiative)
- ► Continue advocacy for education related issues, including media literacy.

Summary of fiscal year 2024 accomplishments and activities

Active participants in Media Literacy, Youth Engagement, Equity, Access and Inclusion, and Assessment committees of DemocracyReadyNY, advocating for

- media literacy legislation supporting media literacy curriculum and teacher professional development
- ➤ As representative of DemocracyReadyNY to CiviX-Now's artificial intelligence (AI) workgroup, contributed to a report on AI and Civic Education and spoke on a national panel on the topic
- Working member of NYC Civic Coalition Steering Committee and Civic Fair workgroup. Collaborated with other youth facing organizations to create a Youth Civics Hub online and participated in kick-off event to connect students to opportunities for civic engagement/participation
- ► Working Member of the NY State League Youth Chairs committee

PROGRAM COMMITTEE

Main objectives for committee

- Identify social and political topics impacting New Yorkers to inform, educate and engage on a variety of issues
- ► Contact expert speakers who will provide non-partisan information on key topics
- ► Prepare the event space, coordinate the catered lunch and manage speaker details
- ► Inform and promote events to the League membership and the community

Summary of fiscal year 2024 accomplishments and activities

2023-2024 was a landmark year for the program committee.

- ► This year's series featured such city and state leaders as NYC Comptroller Brad Lander, two former Manhattan Borough Presidents, Ruth Messinger and Gale Brewer, the Deputy Mayor for Housing, Economic Development, and Workforce Marie Torres Springer.
- ► Topics ranged from Congestion Pricing in NYC, How to Make E-Vehicles Safer for the rider and pedestrian and the Challenges of Undocumented Immigrants
- ► Attendance ranged between 35 and 60 guests each month.

STUDENT INTERNSHIP PROGRAM

Main objectives

- ► Engage High School and College students in the work of the League of Women Voters of the City of New York.
- ► Educate students on the elements of civic engagement and grassroots organizing in diverse communities of NYC.
- ▶ Encourage leadership and initiative.
- ▶ Diversify the League's membership by welcoming these student members

► Empower students to activate civic engagement on their college campuses.

Summary of 2023-2024 accomplishments

The 2023 Summer intern cohort of 20 college students:

- ► Attended weekly seminars with League specialists and partners
- ► Trained to run voter registration drives
- Participated in and organized Citywide Participatory Budgeting balloting, Voter Registration and GOTV events
- ► Pursued independent projects on Voter turnout, Erased Suffragists, Voting in Jails and others

Through the 2023 General Election and into Spring 2024, 2 local interns have participated in outreach events and assisted in the refresh and update of League election information and presentations.

TRANSPORTATION COMMITTEE

Main objectives for committee

► The NYC Transportation Committee remains dedicated to advocating for a sustainable, equitable, and accessible transportation system in New York City. Recognized as the lifeblood of the city, our transportation network is vital to the daily routines of all New Yorkers. Through strategic coalition building, targeted advocacy, and proactive policy change, our commit-

tee strives to enhance the efficiency and safety of this essential system.

Summary of fiscal year 2024 accomplishments and activities

This past year, the committee has been involved in several impactful initiatives including:

- ► Advocating for the appropriate use of Outer Borough Transit Fund accounts by supporting the writing of letters to state leaders to allocate these funds for transit improvements rather than toll rebates.
- ▶ Supporting a coalition memo that promotes policies requiring cost estimates for needs assessments on future expansions of the MTA which is essential for strategic growth and transparency.
- ▶ In partnership with the Riders Alliance, we supported and championed the #6MinuteService campaign, aiming to increase service frequency, thus saving valuable time for riders and making more of the city accessible from every neighborhood.

In the year ahead, the committee is eager to continue our mission and expand our efforts. We aim to grow our membership and further our advocacy to ensure that New York City's transportation system serves as a model of accessibility, equity, and environmental responsibility. We invite new members who are passionate about urban mobility and making a tangible difference to join us in these endeavors.

VOTER SERVICES COMMITTEE

Main objectives for committee

- ► Provide non partisan information and material to New Yorkers about voting and elections
- ► Host voter registration and get out the vote events throughout NYC
- ➤ Offer voter registration training sessions to partner organizations to extend League's reach
- ► Conform League voting and election related materials to disability community members who are hearing or visually impaired
- ► Provide voting and election voting information in multiple languages

Summary of fiscal year 2024 activities and accomplishments

- ► Conducted hundreds of VR and GOTV voter outreach events, at schools, libraries across the city, YMCAs, parks, local businesses, religious organizations, senior centers and many other locations working with League valued partners
- ► Initiated regular series of outreach events with with significant NYC institutions such as the New York Historical Society's monthly "History After Dark" and the YMCA of Greater New York
- ▶ Piloted program training high school student "Civic



Ambassadors" to civically activate their peers

- ► Target voter outreach events, like the YMCA's Equity, Inclusion & Diversity Education Expo
- ► Refined and simplified website Volunteer Form and helped implement a website Volunteer Opportunities Calendar in order to attract new volunteers
- ► Encourage volunteers to engage with community members who are not eligible to vote by raising their voices in other ways, using information and resources from the Speakers Bureau "Three Pillars of Advocacy" presentation

VOTER SERVICES COMMITTEE: SPEAKERS BUREAU

Main objectives of the Speakers Bureau

- ► Inform and educate New Yorkers about voting and community engagement
- ► Partner with community groups to increase collaboration, volunteerism and membership in LWVNYC
- ► Present programs to businesses to increase civic engagement and LWVNYC membership
- ► Promote the civic presentations on the LWVNYC website and through social media
- ▶ Encourage League members to train as speakers

Summary of fiscal year 2024 activities and accomplishments

- ▶ Revised and finalized Civics presentations and slide decks on the topics of: Adult Civics; Voting; Who Makes NYC Run; Ranked Choice Voting; Redistricting; History of the League
- ► Led over 50 Speaking Events in schools, businesses, community groups throughout NYC increasing civic understanding and engagement

VOTING REFORM COMMITTEE

Main objectives for committee

- ▶ Our committee advocates for electoral reform, in order to fight voter suppression and make voting easier for all.
- ► Each year we aim to advocate for the League's platform of voting issues with legislators and other key decision makers, as well as develop new positions to propose to the Board of Directors when appropriate.
- ➤ This year, we are advocating for issues including same-day voter registration, resources for better election data, increased access to voting in jails, and restoration of voting rights for currently incarcerated people. If our League adopts our proposed position on moving NYC elections to even-numbered years, we will also seek to advocate on this issue.



Summary of fiscal year 2024 activities and accomplishments

- ▶ Conducted spring lobbying meetings with state legislators on key issues, as described above, while engaging new and returning members as meeting leaders.
- ▶ Conducted a study per the Local Program set by the 2023 annual meeting, on the timing of local elections, and held a concurrence meeting with the chapter membership with regard to the proposed new position, in support of moving local elections to even-numbered years. The study included input from other Leagues across the country, other good governance organizations based in New York, and academics who have studied the impact of moving local elections from odd to even years



LEAGUEWIDE ACTIVITIES

Summary of fiscal year 2024 accomplishments

- ▶ 9,000 Spanish and English copies of the U.S. Constitution were handed out in twelve low-voter-turnout districts through the 2023 Constitution Day outreach
- ► League idea gathering workshops and conversations with over 160 New Yorkers during Citywide Participatory Budgeting. Spring balloting will reach 2000 more.
- ▶ Alamo Drafthouse in Brooklyn was location for major membership recruitment event - resulting in almost 90 new volunteers
- ► The Updated 2024 version of "What Makes New York City Run?" published in March
- ► LWVNYC motto, "Vote Louder", becomes officially trademarked
